### NATURE OF CONTACT:

U/O responded to 310 S Francis to recover evidence from a possible shooting. Upon arrival U/O made contact with Victim Morin.

### VICTIM STATEMENT:

Morin stated he was at home seated on the couch in his living room at about 1730 hours. He stated he heard a loud bang from outside, which he initially thought may have been a car back firing. However, at the same time a bullet came through his house nearly striking him.

*pop pop bang*

Morin went outside but did not see anyone in the area. Morin stated that just prior to the shooting he was outside and observed a newer model black Charger with tinted windows drive by his house slowly several times. Morin stated the driver made some type of motion towards him with his hand, but he could not tell for sure due to the window tint.

### OFFICER OBSERVATIONS:

*2 in porch 9mm  
1 thru house 45 cal.*

U/O located what appeared to be two bullet holes in the Victim's residence. One was located in the siding of the front of the house, the other was located in the deck railing on the front of the house. U/O was able to follow the entry hole of the round in the siding of the house, which traveled through the SE bedroom wall, through the entertainment center in the living room, striking the solid wood leg of the dining room table, and came to rest on the floor between the dining and living rooms. U/O recovered the bullet, which based on training and experience was a large caliber, likely a .45.

The path of the second round could not be determined due to the fact the round went into the deck railing of the porch and then under the porch, which was enclosed.

U/O took digital photographs of the scene.

### ADDITIONAL INFORMATION:

Morin advised he is known in the neighborhood for standing up against the criminal element in the area. He has been the Victim of home invasions and MDOP's in the past due to this.

U/O was advised that earlier in the day, there were several drive by shootings into a residence at 304 S Clemens (LLA 120401-003372). The Accused in those incidents is believed to be James Jermaine Blue and a .45 caliber weapon was used in those incidents. Although these two scenes are several blocks apart, the caliber of the weapon is believed to be the same. In addition, U/O has arrested James Jermaine Blue in the past driving a black Charger with tinted windows. The vehicle was registered to a female out of Okemos.

EVIDENCE:

- 1. One (1) bullet recovered from 310 S Francis. *.45*

The Victim later called and advised he located two (2) shell casings across the street from his residence. Upon arrival U/O located the casings in between 313 and 315 S Francis. The casing appeared to have been in the elements for some time and were 9 mm. Although it is not believed they are related to today's incident, U/O took custody of them and tagged them in as item #2.
