NOTICE OF ERROR OR OMISSION**

Please be advised that the following errors or omissions were found in a review of your 2019 Pre-Primary Election Statement filed by your committee July 26, 2019. Please file an amended statement in our office by August 16, 2019.

2019 Pre-Primary Election Statement

Cover Page: July Quarterly Statement box should not be checked.

Summary Page: Amounts from the 2018 Annual Statement should be included in cumulative totals.

- Lines 3a, 3c, 5, & 13 should be \$7,876 according to what was reported.
- Lines 18 & 20 should be \$8,371 according to what was reported.
- Lines 8a, 9 & 16 should be \$7,133.85 according to what was reported.
- Line 23 should be \$7,392.85 according to what was reported.
- Lines 4 & 8c should be \$0 according to what was reported.
- Line 13 should be \$235.45 (ending balance from 2018 Annual Statement).
- Line 15 must be completed.
- Line 17 should be \$977.60.

Schedule 1A:

- The election cycle includes contributions and expenditures from the formation of the Committee (9/14/18), until the end of the General Election (11/5/19). Cumulative totals for contributors must include all previous contributions during this cycle, including those reported on the 2018 Annual Statement.
- All contribution entries must include Date of Receipt.
- All contributions must have complete addresses.
- Page 15, Contribution 3 must include complete employer & occupation information.
- Page 18, Contribution 1 may be a duplicate entry. If not, the cumulative total for that entry should be \$400.
- Page 29 Subtotal should be \$675.
- Page 29, Grand Total should be \$7,876.

Schedule 1B:

- Page 1 Subtotal should be \$195.28.
- Page 2, Grand Total should be \$7,133.85.

Schedule 1F:

- The amounts attributed to fundraisers on Schedules 1A & 1B do not correspond with what is reported for the fundraisers. Please review totals.
- Please review the cost of the 6/29/19 Fundraiser. In-Kind Contributions (i.e. dinner) must be reported as a cost of the fundraiser and on Schedule 1-IK.
