**2019 Pre-Primary Election Statement**

**Cover Page:**

- July & Annual Statement boxes should not be checked.
- Dissolution of Committee cannot be granted until the candidate is no longer running for office.

**Schedule 1A:**

- Page 1, Contribution 4 must have a complete address.
- Page 2, Contributions 2 & 3 must have complete addresses.
- Page 3, Contribution 1 must have a complete address.
- Page 4, Contribution 1 must have a complete address.
- Page 5, Contribution 1 must have a complete address.
- Page 5, Contribution 4 must have the complete name and address of the contributor. If a contribution is received without name and address information, it must be donated to a tax-exempt charitable organization and a receipt is needed for committee records.
- Page 5 Subtotal should be \$230.
- Page 6, Contribution 1 must have the Type of Contribution.
- Page 6, Contribution 2 must have a complete address.
- Page 6, Grand Total should be \$1,649.81

**Schedule 1-IK:** Contribution must have a complete address.

**Schedule 1B:**

- Page 1, Expenditures 2, 3, & 5 must have a complete address.
- Page 2, Expenditure 5 must have complete name(s) and address(es) for each individual transaction.

**Schedule 1F:** Schedule 1A indicates that only \$230 in contributions were attributed to fundraisers. Please review totals.
