- LEIN information has been redacted pursuant to Mich. Admin. Code R. 28.5208 and MCL 15.243(1)(d).



You are entitled under the Michigan Freedom of Information Act, MCL 15.240a, to appeal a FOIA fee that you believe exceeds the amount permitted under the City's written Procedures and Guidelines to the President of City Council or to commence an action in the Circuit Court for a fee reduction within 45 days after receiving the notice of the required fee or a determination of an appeal to the President of City Council. If a civil action is commenced in court, the City is not obligated to compete processing the request until the court resolves the fee dispute. If the court determines that the City required a fee that exceeded the permitted amount, the court shall reduce the fee to a permissible amount.

INFORMATION

While working light duty at LPD Ops, I was dispatched to call [REDACTED] who advised and ex co worker she knew is currently calling her and harassing her on a daily basis. [REDACTED] believes the number is a fax machine that is programmed to call her everyday. [REDACTED] is going to start the process of obtaining a PPO while this is under investigation.

VICTIMS STATEMENTS ([REDACTED])

I made contact with [REDACTED] over the telephone. I asked [REDACTED] if she could tell me what happened. [REDACTED] advised she is the [REDACTED]. During 2017 [REDACTED] asked the accused Michele Roman to be on the board of the [REDACTED] along with others. As time went on, [REDACTED] stated that Michele became unruly and hard to work with. [REDACTED] advised Michele would say inappropriate things and voiced very strong opinions that the board did not agree with.

In September of 2017, [REDACTED] advised that she informed Michele that she was no longer needed on the [REDACTED]. Michele was not happy about this and she informed [REDACTED] "anyone that goes against me, I will make their life pure hell and they wont even know about it". Shortly after Michele told [REDACTED] this, [REDACTED] began getting strange calls from an "800" number. [REDACTED] did not know the full number that was calling her when we spoke on the phone. [REDACTED] advised she would get it from her phone once she got off the phone with me and [REDACTED] stated she would send it to me via email.

The 800 number began calling [REDACTED] at her house all times of the day and night. [REDACTED] advised she did not think much about at first. As time went on, [REDACTED] began to think that Michele may be the one calling her from a different number to harass [REDACTED]. Approximately 2 weeks ago per [REDACTED] she "googled" the number that kept calling her day and night. [REDACTED] advised she had to put her phone number into the search engine. Then a "Do Not Call List" came up and [REDACTED] followed the instructions to see who was calling her. Once [REDACTED] put her phone number in, Michele Roman's name came back to the 800 number that was calling [REDACTED]. [REDACTED] decided to contact Police regarding this issue.

EVIDENCE

[REDACTED] advised she has screen shots of the calls and things sent from Michele to [REDACTED]. [REDACTED] advised she would email me any relevant information. No emails from [REDACTED] during the time of this report being typed.

OFFICER ACTIONS

After [REDACTED] gave me all the information for this report, I gave [REDACTED] the police report number. Also, I gave [REDACTED] PPO information over the the phone and advised her to call the PPO office for more information.

ACCUSED (Michele Ramon)

It is unknown where Michele is at this time. [REDACTED] described Michele as a W/F, 5'6 in height, average to medium weight/build. [REDACTED] stated that Michele has "shoulder length blonde-ish brown hair". [REDACTED] thinks Michele has brown eyes and Michele lives with her parents. [REDACTED] advised her parents names are [REDACTED] and [REDACTED].

I plugged Michele's address into TLO and found her name linked to [REDACTED], Lansing, MI 48912. Also, Michele's parents [REDACTED] and [REDACTED] were on TLO at the same address.

While working light duty at LPD Ops, I contacted [REDACTED] in reference to the email attachments she sent me. These attachments are attached to the report and will be described below.

DATE AND TIME

09/05/2019 at 1000 AM

PHOTOGRAPHS/SCREEN SHOTS

[REDACTED] was able to send me screen shots of some of the evidence she has obtained over the past year.

800 number screen shot- This was the "800" number that would call [REDACTED] at all hours of the day.

"Do Not Call List"- This was the website [REDACTED] plugged the 800 number in to find out where or who the number was coming from.

FOIA request- [REDACTED] advised [REDACTED] (who is on the board, among others) works for [REDACTED] and Michele came to [REDACTED] requesting FOIA information on several board members including [REDACTED]. [REDACTED] advised that this "made no sense". [REDACTED] stated that [REDACTED] has nothing to do with [REDACTED] that [REDACTED] and other board members are on. It is unclear why Michele requested this FOIA at this time.

[REDACTED] letter [REDACTED] advised that over a year ago, Michele and [REDACTED] were both on the board of the [REDACTED]. [REDACTED] stated that [REDACTED] and Michele became close and both would bring up sensitive topics at the board meetings. [REDACTED] advised that [REDACTED] and Michele were both removed from the board at the

same time (April, 2019). [REDACTED] advised that [REDACTED] did not show up to the meeting when he was going to be told that he was no longer needed on the board.

"Injustice" screen shot- [REDACTED] advised that Michele started this "Injustice" group on nextdoor.com. [REDACTED] advised this meeting is supposed to take place at United Methodist Church, Downtown tonight (09/05). [REDACTED] advised that is the church that [REDACTED] goes to. [REDACTED] also believes that the minister at this church [REDACTED] is not aware of [REDACTED] and Michele's intent or message they want to portray at this meeting. [REDACTED] advised the meeting is supposed to take place at 1800 tonight.

ADDITIONAL

It should be noted that in my previous report, I had mentioned that Michele was asked to leave the board in September of 2017, I clarified with [REDACTED] today and it was September for 2018 when Michele was asked to leave the board. Around this time is when the calls started happening. Also, Michele was not formally let go until April of 2019 after reelection.

Lastly, [REDACTED] has not had an interaction in person with Michele since March 2019 at fund raiser event. [REDACTED] advised that Michele was purposefully not helping with the event and [REDACTED] asked Michele if she would help. [REDACTED] advised Michele told [REDACTED] "what do you want me to do?" when asked if she could help. No interaction in person since then. The following month Michele was formally removed from the board.
