IT IS ORDERED that with respect to Count 1, Defendant is sentenced to the Michigan Department of Corrections for a period of 240 months to 540 months, with credit for 224 days served. Count 1 to be served concurrent with Count 2.

1. You must pay restitution in the total amount of \$51,451.58; \$9,664.75 payable to James and Mary Whitaker; \$41,786.83 payable to Ingham County Sheriff Department. Subject to adjustment at a restitution hearing or by stipulation of the parties. You must execute a wage assignment to pay restitution if you are employed and miss two regularly scheduled payments.
2. You must pay State cost in the amount of \$68.00.
3. You must comply with DNA testing as ordered by the Court.
4. You must pay a crime victim's assessment in the amount of \$130.00.
5. You must pay Court costs in the amount of \$700.00. **Costs are assessed based on the State Court Administrative Office calculated average costs of a criminal case in Ingham County.


Fines, costs and fees not paid within 56 days of the date owed are subject to a 20% late penalty on the amount owed. If cash bond/bail was personally posted by the defendant, payment toward the total is to first be collected out of that bond/bail and allocated as specified under MCL 775.22.
