Dispatch Information:

On 12/7/2014 at approximately 0130 I was dispatched to the Cedar Creek apartment complex on Okemos Rd. for a suspicious vehicle call. The caller advised that a white Yukon had been driving around the complex for about an hour. A plate was provided, DEC 3360, that dispatch advised registered out of Brighton.

Arrival/Contact with Caller:

I arrived at 0148 hours and drove into the south drive of the complex. The caller was westbound in the drive and flagged me down. The caller was in a S-10 or Sonoma small pickup with an extended cab, dark in color. The caller, a white male, indicated that he was in the complex visiting someone and saw a 2014 or 2015 white GMC Yukon driving around the complex for about an hour. The caller had given the license plate to dispatch. The caller said that the Yukon would drive around the loop of the complex, using the north-south drive at the far east end. The caller stated that they hadn't seen the vehicle in some time, but had called police because they "didn't want anyone to get hurt". There were 3 or 4 occupants of the callers pickup. The caller said that the driver of the Yukon was a white male in his mid to late 20's.

Officer's Actions:

I drove the south drive and didn't see the vehicle. The plate given to dispatch was DEC3360, which was registered to a 2015 GMC. I parked in the east end of the complex to do clerical and watch for the vehicle.

Possible Related Incident:

As I was doing clerical, Ingham County Sheriff's Office deputies got into a pursuit. The deputies indicated that they were pursuing a white Suburban. The pursuit was in the southeast part of the county, and was headed in a southeast direction.

I realized that the vehicle description, direction of travel toward the registered owners' city, and time frame were similar to the suspicious vehicle call I had just been on. I called Ingham County Central Dispatch and spoke with Brittnei Geddert. I advised Geddert that the two calls could possibly be related, and advised that investigators may want to check into it at a later time.

Additional Information:

As I was on unrelated call at approximately 0320 hours, I heard that MSP Troopers had located the white Yukon parked at Cedar Creek Apartments. I responded to that location and stood by while Shroyers was requested by MSP to impound the vehicle. I followed Shroyers first to our impound barn, then to MSP Post 11 where it was secured in a garage.

I will be following up with the caller to obtain his information.
