INFORMATION:

I was dispatched to an assault that had occurred within five minutes of dispatch getting the information from 911. Dispatch information was that there was a man bleeding from his nose in the hallway of the apartment complex, but that the accused was no longer at the scene.

I responded with the Lansing Fire Department Paramedics, who assessed the victim's (John Morin) injuries. The on scene evaluation was a probable broken nose and several loose teeth. The victim was transported to Ingham Medical for follow up care.

The accused are three black females. No weapons were seen and witnesses on scene could only provide a very basic description of what the three accused looked like. I did not make any contact with the accused for interview or arrest.

VICTIM'S STATEMENTS (JOHN MORIN):

Mr. Morin stated that he works as a maintenance person at the Woodbridge Manor Apartments. Mr. Morin also lives in apartment #201, but has never had any problems with working and living in the same place until now. Mr. Morin stated that he walked home from the rental office after punching his time card for the end of the work day. After Mr. Morin walked home, he was met by his girlfriend (Shannon Hallam) and 7 to 8 of her family and friends inside the apartment.

Mr. Morin stated that once inside his apartment, he said hello to everyone inside and took his work boots off at the door. Mr. Morin stated that he did not know most of the guests in his apartment, but trusted his girlfriend's judgement to have reasonable people inside. Mr. Morin's girlfriend told him that there were unknown black females outside in the parking lot who threw something at the sliding glass door of the apartment. The window did not break and was not damaged.

As Mr. Morin's girlfriend (Ms. Hallam) was explaining what happened earlier with the window, Mr. Morin heard a loud bang from the patio door. Mr. Morin suspected that the people outside threw an ice chunk into the door for an unknown reason. Mr. Morin announced to everyone in the house that he would go outside to handle the situation.

Mr. Morin went outside onto the apartment complex stairs in order to talk with the three black females about throwing some object at his apartment patio door. Mr. Morin stated that he attempted to talk to the accused in a calm, slow, and professional manner but that the three accused would have nothing to do with being nice. While on the apartment entrance steps (concrete stoop), Mr. Morin stated, "Please don't throw stuff at my window." One of the accused, whom Mr. Morin knows as "Sharon" said, "Fuck you. What the fuck is your problem? All of you motherfuckers are looking at me and flipping me off inside your apartment." Mr. Morin told the accused calmly that he just got home from work and knew nothing about what was going on inside. Mr. Morin stated to the accused that no one inside of his apartment that he knew of was causing a problem or being belligerent.

Mr. Morin stated that the accused would not listen to him and became enraged with anger. Mr. Morin stated that all three accused started yelling as loud as they could, but that he

can not remember exactly what was said. Mr. Morin stated that the three accused were standing on the sidewalk between the apartment complex and the parking lot. Mr. Morin told the three accused, "You are the ones with the attitude here. I have come outside to try to talk to you calmly, but all you give me back is attitude." The three accused advanced onto the apartment steps outside of the complex where Mr. Morin was standing. The accused known as "Sharon" stated, "You are full of fucking shit. We are here to kick some ass now and get this shit over with."

Mr. Morin stated that one of the accused went behind him. He told the accused calmly that this problem could be worked out, and that we can talk with Sharon's boyfriend "Doug" at Mr. Morin stated that he was shaking with fear and was surrounded by the three accused.

The accused told Mr. Morin that Doug should go to the rental office so that management could get involved. Mr. Morin told the accused that was a fine idea, and at the same time heard the female in the back of him say, "Fuck this white honkey. Let's fuck this white bitch." Mr. Morin turned around to face that accused, when she put her finger approximately 1 inch from his right eye. Mr. Morin was surprised when he turned around into the accused and he flinched by reflexing. Mr. Morin pushed the accused hand away from his eye, and the other two that were behind him because he had turned around began to beat him with their fists. Mr. Morin stated that there was absolutely nothing he could do once the three accused started punching and kicking him. Every time that he would try to get to his apartment to call the police, the beating would get more furious and all he could do was cower into the corner just inside the apartment complex hallway.

Mr. Morin stated that he was hit a total of at least 50 times by the three accused. Mr. Morin stated that he does not know two of the accused, but that he knows one only by the first name of "Sharon." The accused named "Sharon" is supposed to frequent to a man named "Doug."

Mr. Morin stated that he has never been assaulted by any of the three accused before. Furthermore, he has never had a problem with "Sharon." Mr. Morin is unsure if the accused were using alcohol or drugs prior to the assault.

Mr. Morin stated that he finally managed to run into his apartment. Mr. Morin's girlfriend and guests were still inside. Mr. Morin told everyone to leave because he wanted to be alone. Mr. Morin sat in his living room alone and did not call the police.

Mr. Morin does want to prosecute the accused if they can be located. Mr. Morin is also going to contact his girlfriend to compile a list of those who were at the apartment during the assault.

INJURIES / MEDICAL TREATMENT:

Mr. Morin was transported by an ambulance to Ingham Medical Hospital (Greenlawn). I saw his nose bleeding steadily. Mr. Morin complained that his nose was broken and that several of his teeth were also loose. | wanted fo 80 to an unsent come due

While Mr. Morin went to the hospital, I had an emergency call of a man with a gun in the same apartment complex. Although unrelated to Mr. Morin's incident, I did have to give the situation my full attention once Mr. Morin was stabilized by LFD. He was treated at the hospital and released and thus I was unable to attain doctor's information and specific injuries documented by the hospital. Mr. Morin stated that the hospital staff put in 3 or 4 stitches into his nose and gave him prescriptions for pain medication. Paramedics Mulder and Salinaz from MEDIC 4 assessed Mr. Morin at the scene and had the initial survey of a broken nose and loose teeth.

WITNESS STATEMENTS (SHANNON HALLAM):

Ms. Hallam was gone prior to my arrival on scene and also not available when I returned to interview Mr. Morin several hours after the assault. Mr. Morin stated that Ms. Hallam saw the incident and that her guests witnessed the assault as well.

WITNESS STATEMENTS (DERRICK FORD):

Mr. Ford lives across the hallway and two doors south of Mr. Morin (specifically #204). Mr. Ford stated that he was using the telephone talking with the apartment manager, named "Judy." While on the phone with the doorway closed, Mr. Ford heard arguing outside in the hallway, just inside the main apartment complex door. Mr. Ford then heard loud screaming and banging and he opened the his door to look outside. Mr. Ford saw the three accused beating Mr. Morin uncontrollably with their fists. Mr. Ford heard the accused say, "Take this you motherfucker! Try to put me out now!" Mr. Ford heard Mr. Morin say, "Just please God, leave me!" Really.

Mr. Ford stated that Mr. Morin was beaten at least 40 times with fists and kicks by the accused. No weapons were seen. Double the easily but in a beast

Mr. Ford told Judy that a fight was in the hallway and then hung the phone up with her. Mr. Ford described the accused as the following:

- 1. Black female, approximately mid 30's, short and thin. He can not recall what she was wearing whatsoever.
- 2. Black female, approximately mid 20's, short and thin. She was wearing a light color hat and blue jeans. He can not recall what color of shirt she had on.
- 3. Black female, totally unknown clothing.

WITNESS STATEMENTS (JIM EKINS):

Mr. Elkins is the Manager for Woodbridge Manor Apartments. He responded with witness Tom Brewer, who also works at the complex. Mr. Elkins came into the parking lot and saw the three accused run outside. All three accused got into a black convertable and speed off from the parking lot. Mr. Elkins wrote the license plate number down and stated that it is NTK07. Mr. Elkins is sure that the number was copied without error.
