Moreover, I understand that even if I suffer future losses, damages, disability, suffering or the result thereof, or in the event unexpected complications arise, I may never make any claim for more money from the Released Party, or his/her insurers and indemnitors. I further agree that I have accepted payment of the sums specified herein as a complete compromise of matters involving disputed issues of law and fact.

In making this settlement, I have relied entirely on my judgment and that of my attorneys (if applicable). No statement made by any representative of the Released Party, or its/ their insurers and indemnitors, concerning either the nature or extent of my losses, damages, disability, suffering or the result thereof, or the legal liability or financial responsibility of the Released Party, or his/her insurers and indemnitors, has led me to make this settlement.

I understand that the settlement and release made and effected hereby is a compromise settlement and that neither this Release in Full nor the payment made pursuant hereto is to be construed as an admission of liability, the same having been expressly denied.

I further declare and represent that no promise, inducement or agreement not herein expressed has been made to me and that this Release In Full contains the entire agreement between me and the Released Party and its / their insurers and indemnitors, and that the terms of this Release in Full are contractual and not a mere recital.

I further declare and represent that the foregoing Release in Full has been read and understood by me before signing thereof.
