The identification number appearing above has been assigned to your committee. This number must be used on each page of all subsequent statements, reports, correspondence or other communications filed or submitted by your committee. **Your request for a Reporting Waiver has been granted.** Committees with the Reporting Waiver are not exempt from keeping records of the committee's financial activity. Candidate Committees lose their Reporting Waiver if they receive or spend more than \$1,000.00 for an election. This includes In-Kind donations made by the candidate or others. When the Reporting Waiver is lost, the committee must file campaign statements.

If you lose the Reporting Waiver, failure to file the required reports by the filing deadline will result in late filing fees.

It appears you will be a Lansing City Council At-Large candidate, which is a local office in a district with a population of 85,001 – 250,000. In the event the committee does fundraise or expend funds, the contribution limit you are able to accept from an individual is \$2,100.00 for the election cycle and the limit for contributions from an Independent Committee or County PAC is \$21,000.00. A copy of the filing dates and deadlines are enclosed for your reference.

**In addition, please be sure to review the Michigan Campaign Finance Act, MCL 169.201 *et seq.* and the Michigan Bureau of Elections' Candidate Committee Manual, for proper knowledge of the use of campaign funds, resources, and filings. The use of public resources (including emails) is prohibited for the purposes of campaigning. Printed political signs and mailers, broadcast media, and electronic media (i.e. paid ads on Facebook and Twitter) must identify the person or persons paying for the communication with a disclaimer, "Paid for by [Committee/Person Name], [Address]."**
